B.1. *Describe your organization's participation in State efforts to develop and implement measures to strengthen institutional capacities for safeguarding intangible cultural heritage (ICH) (Article 13 and Operational Directive (OD) 154), e.g. in the drafting of ICH-related policies or legislation, in the establishment of national ICH committees or in other government-led processes.*

CCFU contributed to the review of the 2016 National Culture Policy in 2018/2019, strengthening government's and practitioners' culture promotion framework, including ICH. CCFU coordinated a UNESCO-supported project, under which a Bachelor of Cultural Heritage Studies, with the bulk being courses on ICH, was developed by 4 Ugandan universities (Kyambogo University, Islamic University in Uganda, Uganda Martyrs University and Kabale University). Over 20 university staff were trained on delivering the ICH courses, and a national symposium was held to discuss the role of ICH in development and to popularise the degree programme.

In 2019, CCFU conducted a national symposium to create awareness on the link between Culture (including ICH) and the Sustainable Development Goals

CCFU participated in the review of the Principles for Social Impact Assessment and Accountability Bill for the department of Equity and Rights for the MOGLSD (2017).

CCFU contributed to the development of a national proposal on interventions for the protection of the cultural rights of the Batwa and other Indigenous Minority Ethnic groups (IMGs) in Uganda (2018/2019). Most of the provisions refer to their ICH. The initiative was led by the Ministry of Gender, Labour and Social Development.

CCFU collaborated with the Uganda National Commission for UNESCO (UNATCOM) to build the capacity of selected local government authorities on mainstreaming Culture in local government plans. This included building the capacity of local government and historic building owners to effectively safeguard their buildings and use them for entrepreneur benefits such as tourism.

CCFU influenced and supported Uganda's National Curriculum Development Centre to include the topic, Culture and Ethnicity in the East African region, in the lower secondary school curriculum. The module largely focuses on promoting Uganda's national cultural values.

CCFU was part of the Evaluation Body for ICH State nominations and for ethical standards could not participate assist Uganda in the preparation of nominations.

CCFU supported the governments of Kenya, Burundi and Seychelles to compile and prepare ICH nomination files for safeguarding their respective ICH elements.

CCFU has inventoried the ICH connected to 10 riverbank cultural heritage sites: 9 in the Rwenzori region and 1 along the River Nile in Alur, West Nile region. The relevant communities, local government authorities, as well as spiritual and cultural leaders have been actively involved in all the stages of the process. Their cultural institutions were also intimately involved in the process.

CCFU has served on the Evaluation Body for 5 years. During this period, CCFU contributed to the review and improvement of the Operational Directives of the vetting process for the safeguarding, funding and best practices.

CCFU facilitated public lectures in 4 universities in Uganda, linking various aspects of ICH to development aspirations of local communities and Uganda at large. ICH practitioners from local communities where the universities are located participated in the public lectures.

We also implemented projects demonstrating the relevance of ICH in the development agenda, including conservation (specifically of the chimpanzee, an endangered great ape), climate change (especially, regarding the melting of snow from the Rwenzori mountains, and the impact of river flooding on the value and features of cultural heritage sites along river banks in the Rwenzori and Alur regions).

The Foundation supported the Madi Community Museum in Moyo district to develop and display an information board on the Madi bow-lyre music and instrument through the museum spaces. This was intended to provide young people in school heritage clubs and community members with access to information regarding the bow-lyre instrument which is threatened to extinction. The Foundation further supports Koogere Foundation Community Museum in Tooro (western Uganda) to promote the Koogere Oral Traditional especially among young people in 7 school heritage clubs.

CCFU in collaboration with the Peace Museums in Kenya organised a heritage competition for young people on the ICH elements that promote peace and unity in their communities. The competition attracted more than 400 participants and this resulted into the development of the CCFU 2020 national calendar.

During the reporting period, CCFU engaged young people through their school Cultural Heritage Clubs to learn about their culture. Annual heritage competitions were organised for young people in Schools and communities focusing on various themes including cultural practices that promote social cohesion in communities, cultural resources that demonstrate the concept of beauty, and the relevance of traditional games. The 2019 competition on culture and social cohesion involved the Peace Clubs from Kenya. Resource information and education materials were produced including a review of a toolkit on Heritage for young people and an annual

heritage calendar.

Every year, we integrate awareness raising agenda in the commemoration of World Culture Day, International Mother Tongue Day and the International Day of Indigenous Persons.

Some of the oral history of indigenous Ethnic minorities such as the Lendu, Ngokutio, the Batwa and Nyangia has been documented. Reference materials tailored for young people on their ICH elements were also developed to support intergenerational learning and sustainability.

Teachers, community museums curators, owners of historical building and civil society members have also received capacity building training from CCFU on mainstreaming culture in development work

CCFU participated in the East African JAMAFEST where we presented a paper on culture, science and ethics.

Prof. Herbert Chimhundu from Zimbabwe was invited and presented (virtually) on the ICH promotion collaborations in Southern Africa, during the evaluation meeting of the “promoting ICH Education in institutions of higher learning” project which CCFU has been coordinating.

CCFU has participated in Committee meetings for the all the years under review. These included ICOM 13, 12, 11, and 10.

CCFU made presentations and shared her experiences in various interventions for example heritage education in schools at ICOM 10 and 11 in Ethiopia and in South Korea, respectively.

CCFU, as a member of the Evaluation Body engaged with an IGC committee that was set up to discuss matters concerning resolution of voidable recommendations of State applications, and delivered a presentation on ICH at University at the ICOM meeting in South Korea.

CCFU also supported in rapporteuring at the ICOM meeting in Addis-Ababa.

Yes, CCFU has served as a member of both the Evaluation Body from 2015 to 2019 and the Consultative Body from 2013 to 2014

As a member of the Evaluation Body, CCFU evaluated State files for nominations for safeguarding ICH elements, and proposals for funding towards the safeguarding of ICH elements. CCFU also provided its opinion regarding issuance of consent of children in the nomination of safeguarding ICH elements.

Yes, CCFU foresees providing these services in the future if nominated.

CCFU has served as a member of the Evaluation Body for 5 years. This provided an opportunity for CCFU to utilise her expertise and capacities in evaluating nominations, proposals and requests. CCFU has the capacity to evaluate nominations in both English and French. 4 staff have strong competence in English while an additional 1 staff has competence in both English and French.

E.2. *Does your organization have experience in working across several ICH domains? Please describe your experiences.*

Not to exceed 250 words

Yes. CCFU has implemented a number of projects aimed at increasing awareness and visibility of ICH in communities, safeguarding spaces and sites of historical and cultural significance while ensuring community participation and inventorying. These include awareness raising of cultural practices, norms and values that promote the rights of women and girls in various communities in Uganda, documenting oral history of indigenous minority people especially those at most risk of extinction, supporting the process of enactment of bye-laws and ordinances that protect spaces, buildings and sites of cultural and historical significance and setting the pace for the establishment of the first ever railway museum in Uganda.

CCFU has supported capacity building initiatives by other organisations and communities in the processes of inventorying and documentation of their ICH elements. This has resulted in the protection of some cultural heritage sites such as Wanglei in North Western Uganda and several sites along the Rwenzori Mountain ranges in Western Uganda.

CCFU has supported the Ministry of Gender, Labour and Social Development to review policies that promote and protect ICH in Uganda.

E.3. *Describe the experience of your organization in evaluating and analysing documents such as proposals or applications.*

CCFU has experience in analysing documents and proposals. CCFU served as a member of the Evaluation Body for 5 years. The terms of reference included analysing and evaluating state files submitted for the safeguarding of ICH elements. Among other responsibilities, as a member of the Evaluation Body was to assess and provide recommendations to State or organisations applications for funding from UNESCO ICH. CCFU also served on the ICH 2003 NGO Forum editorial committee of the Heritage Alive publications and contributed articles too.

E.4. *Does your organization have experience in drafting synthetic texts in English or French? Please describe your experience and indicate in which language(s) and the number of those members or staff.*

Yes. CCFU is competent in drafting synthetic texts in both English and French. We have also been commissioned to develop training materials and a toolkit by UNESCO – ICH section. CCFU served on the Evaluation Body as a member and during the time, in 2015/16 was secretary to the Body. CCFU was responsible for drafting and presenting the Evaluation Body report to the IGC meeting.

E.5. *Does your organization have experience in working at the international level or the capacity to apply local experience to an international context? Please describe such experience.*

Yes, CCFU has supported work on promoting heritage education at the international level. CCFU has provided technical guidance to the Asian ICHCAP on implementing heritage education in schools and tertiary institutions. CCFU has also provided support to Kenya, Burundi and Seychelles on the preparation process of State submission of ICH elements for safeguarding and listing.

F. Cooperation with UNESCO

CCFU has been coordinating a 2-year project to promote ICH at institutions of higher learning. The project was mostly funded by UNESCO and has successfully culminated into the establishment of the first ever bachelor's degree in Heritage Studies in 4 Ugandan Universities. The evaluation meeting of this project's performance proposed taking the project to other countries, especially in Eastern Africa.

In 2018 and 2019, CCFU provided technical support to Burundi and Kenya in preparation for submission of their State files on safeguarding ICH elements.

CCFU contributed articles to the Heritage Alive publications and served as member of the editorial committee.

The Foundation was also commissioned to develop training materials and a toolkit by UNESCO – ICH section
